 04 Festival for the festival cycle that begins September 1, 2008 and ends September 30, 2009. The
 05 author(s) permit the Festival to produce the staged reading and/or the public performance without
 06 paying royalties, as it is understood that this festival is a competition and the only remuneration will be a
 07 trophy awarded to the winning play submitted, based on a judgment by a team of jurors selected by the
 08 festival.

09 I/we, the author(s), affirm that the play named in this document is my/our work of art, and that I/we own
 10 the copyright to the material as it is presented in any form. I/we give permission to the Festival to
 11 present this play for a staged reading and performance within the common guidelines established and
 12 amended, for this festival. This permission begins effective with the submission of this play, and
 13 terminates with the final presentation of the award for "Best Play" of the Florida Playwrights Festival,
 14 except that the Festival may make video reproductions of this play, for submission to a list of play
 15 producers/director in New York, for the benefit of the author(s).

16 I/we, the author(s), affirm that the author(s) own the copyright to the body of work listed below in its
 17 entirety, and that the Festival will be held harmless and without blame for any infraction of that copyright
 18 from the date the play is submitted until the day the final presentation of awards is made by the Festival.

 20 play production venues in New York City, NY, for the benefit of the author(s), and that any additional
 21 production of this play will be because of agreements between the author(s) and the producing company
